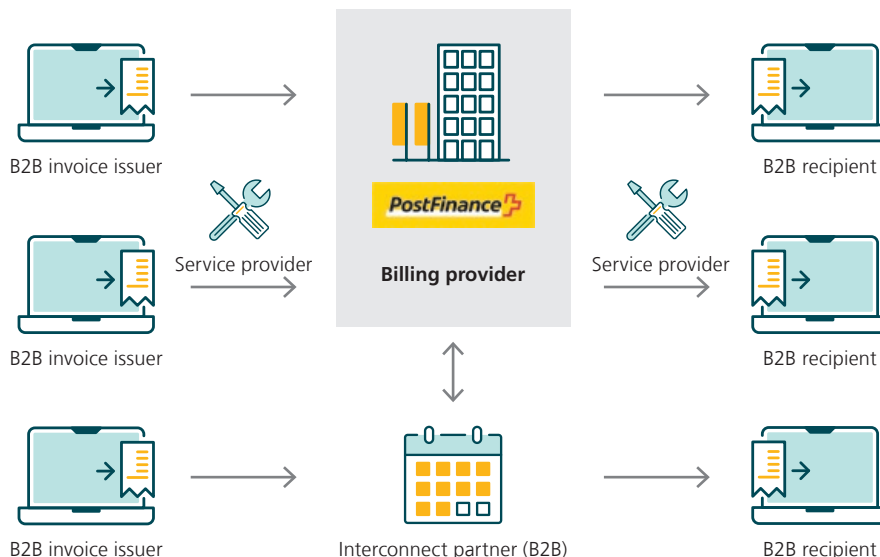

### Prices and conditions

The price level depends on the number of digital invoices sent and/or received per customer and per month.

Number of digital invoices per month	Receiving B2B invoices
Up to 1,000	CHF 0.50
Up to 5,000	CHF 0.45
Up to 10,000	CHF 0.40
From 10,000	On request

Transactions amounting to CHF 8 are included free of charge each month in the price level of up to 1,000 invoices.

Value-added services	Price
Surcharge for receiving from third-party system subject to a surcharge (Interconnect)	CHF 0.10 per invoice
